The quotations addressed to the undersigned kept in a sealed cover should reach latest by **30 Dec 2011 at 17:00 hrs.** The quotations should be submitted on the above address. The cover should be prominently super scribed with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE". The vehicle and its documents will be available for inspection with prior appointment on telephone from **23 Dec 2011 to 27 Dec 2011** between **02:00 PM to 04:30 PM** at Gate No. 19, Udyog Bhawan, New Delhi.

3. The quotations received in time will be opened by the Tender/Disposal Committee on **03 Jan 2012 at 17:00 hrs in Room No. 517-A Udyog Bhawan, New Delhi.** The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotations.

4. The sale will be governed by the following conditions:-

i) The bidder is required to pay Earnest Money of Rs. 5000/- (Rupees five thousand only) by means of Demand Draft/Pay Order drawn in favour of Accounts Officer PAO(DIPP), New Delhi.

ii) Quotations received without demand draft/pay order towards Earnest Money will be rejected.

iii) The successful bidder will be required to deposit the bid amount by means of demand draft/pay order drawn in favour of Accounts Officer, PAO(DIPP) within two working days of the acceptance of the bid.

iv) Earnest Money will be forfeited if the successful bidder fails to, honor the bid. The Earnest Money of the successful bidder will be, released only after transfer of Vehicle Registration in his name.

v) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Ration card/Voter identity Card/Passport in case of individual and Registration Certificate in case of firms etc.

vi) The sold vehicle will be removed by the successful bidder from the premises of Udyog Bhawan within two working days after the issue of sale letter by this Ministry at their own expenses.

vii) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. A copy of the transfer of vehicle in the name of the successful bidder, issued by the Transport Authority shall be submitted to this office within 15 days of its sale positively. This Office will not be responsible for any lapse on his part in this regard.

viii) The vehicle will be disposed of on 'as is where is' basis and no guarantee for its worthiness or quality will be given by this Office.

ix) The bidders is not allowed to withdraw their bid, failing which their Earnest Money will be forfeited.
